American Association of Orthodontists 2021 Attendee Challenge Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- **1. SPONSOR, ADMINISTRATOR:** The American Association of Orthodontists ("AAO" or "Sponsor") shall serve as the sponsor and administrator of the American Association of Orthodontists 2021 Attendee Challenge Sweepstakes ("Sweepstakes").
- **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the 50 United States and the District of Columbia (excluding Puerto Rico and all United States territories and possessions, who are 18 years of age or older at the time of entry. - **3.** CHALLENGE PERIOD: The Attendee Challenge begins February 12, 2021, 8:46 a.m., C.T., and ends February 14, 2021, 11:00 a.m., C.T. (the "Sweepstakes Period").
- 4. HOW TO ENTER: You may enter this Sweepstakes only via the entry methods described below (each, an "Entry"). All entries must be received by 11:00 a.m., Central Time, of the last day of the Sweepstakes Period (February 14, 2021), regardless of the method of entry. Proof of depositing entry in mail is not considered proof of delivery or receipt. No photocopied or mechanically produced entries will be accepted. Illegible, incomplete and duplicate entries will be disqualified. Entries will not be accepted from post office boxes. All entries become the property of Sponsor and will not be returned.
 - **a. - **RANDOM DRAWING:** Winners of the Prizes ("Winners") will be selected in a random drawing from among all eligible participants, on or about February 14, 2021 ("Drawing Date") by the Sponsor, whose decisions are final and binding in all matters relating to this Sweepstakes. Failure to return all required documents in this time period may result in the Winner being disqualified and an alternate Winner selected. Sponsor reserves the right to modify, suspend or terminate the Sweepstakes in the event that it becomes necessary due to circumstances beyond Sponsor's control. In the event the Sweepstakes is terminated early, Winners will be selected from all eligible entries received at the time of termination.
