Please note: The Veterans Community Care Program (VCCP) is the official name of the VA's community care program. The Community Care Network (CCN) refers to the network of Third-Party Administrators (TPAs) that VA contracts with to provide these care services. In this document, VCCP and CCN are used interchangeably to generally refer to VA's community care program.


### Who is a Veteran?

In general, a Veteran is a person who served on active duty in the Coast Guard, Army Navy, Marine Corps, Air Force or Commissioned Officers of the Public Health Service and the National Oceanic and Atmospheric Administraiton (NOAA), and did not receive a dishonorable discharge.\*

### **Veterans Eligible for VA Healthcare**

## Are all Veterans eligible for VA Healthcare?

#### No; only veterans who:

- were discharged or released under conditions other than dishonorable
- are former or current Reservists, if they served for the full period of active duty for which they were called (excludes training purposes)
- are former or current National Guard members if activated/mobilized by a federal order for active duty

There are more than 19 million Veterans in the United States, and approximately 9 million are enrolled in VA Healthcare<sup>1</sup>

#### **DID YOU KNOW?**

Many Veterans don't selfidentify. Asking if someone has "ever served" results in more accurate responses than asking if someone is a "Veteran," especially among women.

#### **HEALTH CENTER PRO TIPS!**

- Health Centers can help eligible Veterans enroll in the VA healthcare they've earned by asking everyone "have you served?"
- Health Centers can connect individuals who've served to their local county or state Veteran service officers to determine eligibility and enrollment



### **Veteran Population Snapshot**

#### Veteran Population in the U.S. & Utilization of Community Care

- There are 19.2 million living veterans¹
- 9.3 million veterans are enrolled in VA healthcare system, and potentially eligible to receive care from providers in VA's Community Care Network¹
- 6.2 million veterans received care from VHA in 2020<sup>2</sup>
- 2.7 million veterans were referred by VA for community care since implementation of the VA MISSION Act on June 6, 2019<sup>3</sup>

#### **Veteran Utilization of Community Care**



- While only 14% of veterans have been referred by VA for community care since 2019, FQHCs can still serve veterans in their community regardless of a veteran's enrollment status in VA healthcare.
- In fact, it is estimated that there are over 1.5 million uninsured veterans, and over 2 million veterans who defer receiving care because of cost.<sup>4</sup>

#### Where do Veterans Receive Healthcare?

VA healthcare is the country's largest integrated healthcare system with more than **1,200 care locations**.

#### **Community Health Centers (CHCs) Role:**

■ **Community Care.** If the nearest VA location cannot provide the services a Veteran needs, they can receive care from a provider in their local community through the Veterans Community Care Program (VCCP), provided they meet at least one of the six eligibility criteria (see page 10). Providers that join the VCCP participate in the Community Care Network (CCN).

#### Veterans receive care in the following VA settings1:

- VA medical centers (VAMCs), which offer a range of traditional and advanced hospital services.
- VA community-based outpatient clinics (CBOCs), which provide the most common outpatient services (like health and wellness visits) for routine appointments in a convenient location.
- Vet Centers, which provide community-based counseling, outreach, and referral services to Veterans who served in a combat zone as well as to their families. Mobile Vet Centers also help bring care to more rural locations.

- which support Veterans who need more intense nursing care and help with everyday tasks.
- Veteran's own home. If needed,
  Veterans may get medical treatment,
  nursing care, or help with everyday tasks
  in the comfort of their own home.

## Why NACHC is Working to Expand Health Center Capacity to Serve Veterans

Veterans are often forgotten – but are valuable members of our communities who have struggled with access to high quality healthcare in places where there's not an existing VA facility

For over 50 years, health centers have proudly served Veterans and their families in need of care. Serving Veterans is enabled by VA authorizing legislation (VA MISSION Act 2016, 2018):

- Section 101 of the VA Mission Act specifically identifies that any Federally Qualified Health Center (FQHC) may provide care to eligible Veterans under the provisions of the VA VCCP
- The MISSION Act makes it easier for Veterans to access the local health care they need, when and where they need it

#### **Providing care to Veterans in our communities:**

- Is aligned with a FQHC's mission to ensure access for all
- Provides an opportunity for potential additional revenue
- Creates community impact
- Offers opportunity for partnership with Veteran Service Organizations, Veteran Service Officers, and other Veteran-focused non-profits or philanthropic organizations

#### **Who Can Receive Community Care?**


### Under the MISSION Act, there are six eligibility criteria for a Veteran to seek community care:

- The specific care they need is not provided by any VA facility
- They reside in a U.S. state (AK, HI, or NH) or territory (Guam, American Samoa, Northern Mariana Islands, or U.S. Virgin Islands) that does not have a full-service VA medical facility
- They have "grandfathered" eligibility based on their residence and the 40-mile eligibility criterion from the Choice program
- The specific care needed is not available within designated access standards
- The Veteran and their referring clinician decide it is in the Veteran's best medical interest to seek specific care in the community
- 6. VA has designated the VA medical service line delivering the specific care needed as not providing care that complies with VA's standards for quality

If a Veteran meets any of these criteria, they are eligible to receive care from a community provider in VA's network.

#### Why Health Center Capacity Matters for Veterans

Nationally, nearly 1,400 HRSA-funded health centers operate over 12,000 sites and provide care to **29 million people; over 385,000 are Veterans<sup>2</sup>**.




The VA can't be everywhere. With 1,239 VA sites across the country, community health centers help fill the gap in thousands of communities.

About 95% of health centers and 70% of health center look-alikes served Veterans in 2018.

#### **Health Centers Increase Access for Veterans**







#### **Veteran Community Care Program**

Community Care Network (CCN) is a high-performing network of credentialed healthcare providers and practitioners that provide medical, surgical, complimentary and integrative health services (CIHS), durable medical equipment (DME), pharmacy, and dental services to Veterans.





The program purchases care for Veterans in their community and is the preferred national network of the VA. When Community Health Centers participate in the VA Veterans Community Care Program (VCCP) they become members of the CCN.

## PROVIDING COMMUNITY CARE TO VETERANS

Over 3,820 Federally Qualified Community Health Center delivery sites currently participate in the CCN, providing nearly 4,000 health services\*.

## Requirements to Become a Community Care Provider:

- Enter into a contract with the TPA for your region of CCN
- Have a National Provider Identifier (NPI) from the National Plan and Provider Enumeration System, which is issued at no cost
- Use NPI and referral number to conduct all business activities with VA, including medical, dental, and pharmacy transactions
- Be credentialed in accordance with the requirements for your region of CCN. Work directly with the TPA to complete the credentialing process
- Work with the TPA to become a preferred provider. Requirements are being established but may include training on Veteran-related subject matters

## Enroll with Regional Third Party Administrators (TPAs) to Join the VA Community Care Program

All Community Health Centers must execute a new contract with their region's TPA, even if they had Choice contracts in place previously.

### **Who Does What in Community Care?**

#### **Key Functions and Roles**

Function	Roles	
Building the Network	<b>TPA</b> has responsibility to build the network and provide a credentialled network.	
Care Coordination	<b>VA</b> does the care coordination with the Veteran and providers.	
Eligibility	VA determines and exchanges information with the Provider	
Referral and Authorization	<ul> <li>VA</li> <li>VA sends referrals to providers through a cloud-based system called HSRM TPA</li> <li>Receives and processes referrals throughout the day (immediately and hourly FQHC</li> <li>Receives referrals from VA</li> </ul>	
Scheduling	<ul> <li>VA</li> <li>Occurs at local VA facility or directly by Veteran</li> <li>Uses master directory of care provider options provided by TPAs</li> <li>TPA</li> <li>Can occur by TPA when the VA Medical Center opts in for this contracted task</li> <li>FQHC</li> <li>Receives appointment request from VA</li> </ul>

## Value of FQHC Services to the VA Community Care Network

- The Community Care Network values all the services provided by FQHC's
- FQHC's are crucial "gap fillers," offering services needed in communities that the VA doesn't fulfill. What those services are varies by community and over time
- If the CCN does not need a particular service today from a FQHC, it does not mean the VA won't need it tomorrow. The needs of the population, as well as the VA services offered, are constantly changing


#### **Partnerships**
